#### COVID

Editor's Note: In the Nov. 15, 2020 city council meeting, Suresh Reddy said he lost his father-in-law to Covid-19 complications in November 2020. At the meeting Reddy spoke in favor of a mask mandate in Johnston.

➤ In September 2021, Suresh Reddy shared a Facebook post encouraging participation in a special school board meeting to support a mask mandate



- ➤ In November 2020, Suresh Reddy voted for a measure requiring face coverings in city-owned buildings in Johnston County for anyone over the age of 2 years, which passed unanimously
  - On Nov. 23, 2020, Suresh Reddy voted for a resolution supporting and approving the proclamation of emergency: mitigation measures including use of face masks in response to the continuing covid-19 public health emergency (Passed 5-0).<sup>1</sup>
  - o In a Nov. 23, 2020, article, KCCI reported, "The Johnston City Council approved a measure Monday requiring face coverings in city-owned buildings.
    - "Effective immediately, anyone over the age of 2 years old must wear masks in buildings owned by the city.
    - "The proclamation also 'strongly and urgently' encourages Johnston residents, employees and visitors to wear face coverings at all times.
    - "Exemptions to the mask requirement include those with medical conditions or disabilities that prevent them from wearing masks.

"Masks are not required for those working alone or when 6 feet of distance can be maintained, while eating and drinking with social distancing measures in place or while giving or receiving a service that requires temporary mask removal."

#### **TAXES**

- > Suresh Reddy does not support a total elimination of the Iowa income tax
  - O In a June 4, 2022, Q&A with the *Des Moines Register*, when asked if he supported a total elimination of the state income tax, Suresh Reddy replied, "No. In my experience as a city councilor, when people are empowered to see where their tax dollars are being invested and how that improves their family's future, they are generally supportive. Let's be clear, slashing taxes means fewer opportunities for Iowans. If I am elected, I promise to make every effort to be accountable and show voters how I voted to invest our money and how that helps them. The bottom line is that I believe in the people of Iowa. That's why I'm confident every investment in our people and communities will pay dividends."
- ➤ In 2021, Suresh Reddy voted for a budget that maintained the same property tax rate as the previous year, but due to an increase in the rollback rate, would cost \$14.19 in increased property taxes for an owner of a \$100,000 home
  - According to the minutes of the March 15, 2021, Johnston City Council meeting, Suresh Reddy voted for a resolution adopting the budget for Fiscal Year 2021-2022 and Authorizing Tax Levies on all Taxable Properties within the City of Johnston (Passed 5-0).<sup>4</sup>
  - O According to the Johnston City Council 2021-2022 Budget Review presentation, the City of Johnston's 2021-2022 property tax levy was set at the rate of 10.63042, the same as tax year 2020-2021. According to the document, the rollback percentage in 2021-2022 rose to 56.4094%, up from 55.0743%, and the property tax for a \$100,000 home increased from \$585.46 in 2020-2021 to \$599.66 in 2021-2022, an increase of \$14.19 per \$100,000 home.<sup>5</sup>

Editor's Note: The 2022-23 property tax rate increased by \$0.05, from \$10.63 to \$10.68. The budget's rollback rate dropped to 54.13%, and the tax bill for a \$100,000 home dropped by \$21.81. #### **RATE INCREASES**

- ➤ In June 2022, Suresh Reddy voted for second reading of a resolution that would increase the sewer rate three times, with 9 percent adjustments each year beginning July 1, 2022
  - According to the minutes of the June 6, 2022, Johnston City Council meeting, Suresh Reddy voted for second reading of a resolution establishing Sewer User Charges effective July 1, 2022 (Passed 5-0).<sup>6</sup>
    - Editor's Note: Third reading vote is expected June 20, 2022. Researcher will update this document once minutes are posted from that meeting.
  - O According to the agenda of the June 6, 2022, Johnston City Council meeting, "Based on cash flows, future projected capital improvements, bond covenant requirements, and changes to WRA expenses based on flow allocations, a rate adjustment is needed. The committee is recommending three 9% adjustments each year beginning July 1st. 9% July 1, 2022; 9% July 1, 2023; and 9% July 1, 2024; with close reviews of the utility cash flow each spring."
- ➤ In June 2021, Suresh Reddy voted for a five percent increase in the sewer rate in Johnston
  - According to the minutes of the June 7, 2021, Johnston City Council meeting, Suresh Reddy voted for a resolution establishing Sewer User Charges effective July 1, 2021 (Passed 5-0).<sup>8</sup>
  - O According to the agenda for the June 7, 2021, Johnston City Council meeting, "Sewer: Based on cash flows, future projected capital improvements, bond covenant requirements, and changes to WRA expenses based on flow allocations, a rate adjustment is needed. The committee is recommending a one-year adjustment of 5% on July 1, 2021 and another close review of the utility cash flow in the spring of 2022. PFM Sewer Cash Flow is attached."
- ➤ In 2020, Suresh Reddy voted to approve the solid waste and recycling fees, which included a \$0.02 rate increase (pass-through fee to the provider) for the Curb It! Recycling program
  - According to the agenda for the June 15, 2020, Johnston City Council meeting, "Per an email received from Metro Waste Authority on February 17, 2020, the rate for the Curb It! Recycling program is increasing by \$0.02 beginning July 1. The current rate is \$3.43 and the new rate will be \$3.45/household/month.

"The rate increase is provided for in the contract MWA has with Waste Management of Iowa and is based on a nationally published Consumer Price Index (CPI) and the compressed natural gas index.

"Fees collected for garbage and recycling services are pass-through fees, the city collects the fee from residents that have service available and sends the fees to Metro Waste Authority. The new fees go into effect on July 1, 2020 and will appear on the August utility bill." <sup>10</sup>

According to the minutes of the June 15, 2020, Johnston City Council meeting,
Suresh Reddy voted to approve resolution 20-142, to a resolution establishing solid waste and recycling fees for 2020/21 (Passed 5-0).<sup>11</sup>

#### **TRANSGENDER SPORTS**

- In a February 2022 Facebook post that linked to an article regarding legislation banning transgender women and girls from competing in girls' sports, Suresh Reddy wrote, "Seeing the hatred and bigotry that just came out of the Iowa legislature breaks my heart. Let's face the facts, transgender youth will suffer, Iowa students and our schools will suffer, and people WILL leave the state because of this bill"
  - o In a Feb. 21, 2022, Facebook post, Suresh Reddy wrote, "Seeing the hatred and bigotry that just came out of the Iowa legislature breaks my heart. Let's face the facts, transgender youth will suffer, Iowa students and our schools will suffer, and people WILL leave the state because of this bill. All for politicians wanting to make headlines." <sup>12</sup>
  - o In a Feb. 21, 2022, article, the *Des Moines Register* reported, "Transgender women and girls would be banned from competing in girls' sports offered by Iowa's schools, colleges and universities, under a bill passed Monday by Iowa House lawmakers.
    - "The House voted 55-39 Monday to pass the bill, with all but one Republican Rep. Michael Bergan, R-Dorchester voting in favor and every Democrat opposed." <sup>13</sup>

# **ABORTION**

- > Suresh Reddy said he will unapologetically defend reproductive rights in Iowa
  - On May 4, 2022, Suresh Reddy tweeted, "Suburban GOP legislators like my opponent try to paint themselves as 'moderate,' but the Iowa GOP's moves to strip Iowans of reproductive freedoms are radical and will cause irreparable harm. I pledge to unapologetically defend reproductive rights in Iowa."<sup>14</sup>

- ➤ In 2022, Suresh Reddy said in the state house, he would "bring Iowans together with progressive policies"
  - o In a Jan. 22, 2022, Facebook post, Suresh Reddy for Iowa posted, "Suresh Reddy is a member of the Johnston City Council who is running for Iowa House District 43 to bring Iowans together with progressive policies, experienced leadership, and a vision for what Iowa can be if we invest in the future. - ➤ Suresh Reddy was a 2020 Joe Biden donor
  - According to the Federal Election Commission, in the 2020 election cycle, Suresh Reddy, a software engineer for Workvia from Johnston, IA gave a total of \$55 to Joe Biden for President.<sup>16</sup>
