### ASPIRING POLITICIAN

## Time In Washington, D.C.

- After graduating from college, Hauschild moved to DC and attempted to build a career as a Washington insider, taking positions in Obama's Department of Agriculture and during the 2012 Obama re-election campaign working simultaneously for the campaign as a regional get-out-the-vote director. He then worked as an aide to Sen. Heidi Heitkamp, working for her as a correspondence manager before returning to North Dakota. - In 2016, after he moved back to his home state of North Dakota, Hauschild posted on his personal Facebook page that he "saw Phantom of the Opera in President Obama's viewing box at the Kennedy Center." (Facebook, 7/23/16)

## Moved To Minnesota After Losing North Dakota Election

- Hauschild is from North Dakota, where he unsuccessfully ran for office in 2016. (*The Grand Forks Herald*, 1/25/16; *The Grand Forks Herald*, 11/9/16)
  - In June 2015, Hauschild moved back to his home state of North Dakota, and about seven months later, in January 2016, ran for House District 42. He lost the race and came in last place of four candidates (the top two both won seats). (*The Grand Forks Herald*, 1/25/16; *The Grand Forks Herald*, 11/9/16)

- Hauschild did not move to Minnesota until in January 2019, when he started working at Essentia
  Health. The Hauschilds purchased their home in Hermantown, Minnesota, in February 2019. (Saint

- Despite working in DC for years and running for office a few years before in another state,
   Hauschild has accused one of his Republican opponents, Kelsey Johnson, of having thin ties to the
   district, claiming she is a "corporate St. Paul lobbyist," and lives in Duluth, outside of the district.

## **Progressive Democrat**

- AUDIO: In March 2017, Hauschild recommended the Pod Save America podcast, led by Obama staffers, to those "feeling a little down about the last election," and said it allowed him to "stay in [his] progressive bubble." (Small State, 3/1/17) Minute 57:41 58:30
- Hauschild has posted on social media about his support for various progressive politicians, including Sen. Elizabeth Warren (D-MA) and Canadian Prime Minister Justin Trudeau. (Instagram, 3/5/20; Instagram, 10/21/19)

## Supports Single Payer Healthcare

• In its 2022 endorsement of Hauschild, the Minnesota Nurses Association praised Hauschild as a "strong supporter of collective bargaining rights," and "single payer healthcare." (Press Release, 5/24/22)

## Supports President Joe Biden's Inflationary Agenda

- In March 2021, Hauschild shared a post on his personal Facebook page promoting "President Joe Biden's American Rescue Plan," which Democrats and Republicans blame for contributing to record-high inflation. (Facebook, 3/18/21; The Washington Post, 2/3/21; USA Today, 5/3/22)
  - O The American Rescue Plan was estimated to increase the federal deficit by \$1.84 trillion, was stuffed with over \$1 trillion in non-COVID relief, and it resulted in several "pork-barrel spending disasters." (Congressional Budget Office, Accessed 10/4/21; Editorial, *The Wall Street Journal*, 2/21/21; *The Associated Press*, 3/23/22)

## Raising The Age For Social Security

• In 2011, Hauschild wrote in an opinion-piece for *The Bismarck Tribune* that "speaking honestly, the elderly must agree to raise the retirement age," and that it is "purely selfish" to suggest the issue is "untouchable." (*The Bismarck Tribune*, 8/9/11)

#### **Voted To Raise Taxes**

- On his campaign website, Hauschild says we need to "keep property taxes from continuing to rise."

- However, Hauschild has voted to raise local and property taxes every year since he joined the Hermantown City Council in 2020.
  - o In 2020, Hauschild voted to raise property taxes by 4.56 percent and local tax rates by 1.96 percent to pay for a 2.53 percent increase in the city budget. (2020, City Of Hermantown, 12/7/20)
  - O In 2021, he voted to raise property taxes by 9.41 percent and local tax rates by 7.14 percent in 2022 to pay for a 7.07 percent increase in the city budget. (2021, City Of Hermantown, 12/6/21)



## **ELECTION INTEGRITY**

In 2016, Hauschild Said If Elected To The North Dakota Legislature That He Would Change The State's Voter ID Law That Required Voters To Have A Valid ID With Their Current Address In Order To Vote. "While the state budget is taking up a lot of the local political conversation, Hauschild mentioned he would like to address the state's voter ID law if elected to the legislature. Last legislative session, North Dakota's voter ID law was changed so that voters are required to have a valid ID with their current address in order to vote. While proponents of this law argue that it clarifies the voting requirements in the state and prevents voter fraud, critics say instances of voter fraud were rare and the new law makes it difficult for certain populations to vote, notably college students and Native Americans. 'This could impact hundreds if not thousands of students if they don't have an updated address on their license,' Hauschild said. 'We had very well run elections and we can again.
