# **MAIN ISSUES**

# Campaign And Political

- Gustafson did not appear to have shown interest in politics until the 2016 election of Donald Trump. Her first political contribution was made to the DCCC in November 2016, after the election. (Heather Gustafson, FEC, Accessed 5/11/22)
  - O Gustafson made small, sometimes repeated \$5 contributions to a large swathe of the 2020 Democratic presidential candidates, beginning with Beto O'Rourke in July 2019, then contributing to Pete Buttigieg, Amy Klobuchar, Elizabeth Warren, and Tom Steyer. Gustafson did not contribute to Joe Biden until March 2020 and, in October, he became the only candidate she made a direct, non-ActBlue contribution to \$70 to Biden For President. - Gustafson purports to be a moderate she promotes her husband's hunting and fishing hobbies and has bragged about their hunting cabin in Wisconsin but has also advocated for liberal and progressive causes and has changed her opinion to fit popular perspectives. - Between July 14th and July 29th, 2022, Gustafson's website was relaunched; her "Issues" section was reformatted as a "Priorities" page and she de-emphasized every one of her initial platforms, including removing her positions to "Legalize Marijuana" and provide "Reproductive Justice."   - O Gustafson pulled back on her call to "replac[e] our current [healthcare] system." ("Issues," Gustafson for Senate, Accessed 6/14/22)
- Instead of providing solutions, Gustafson has concentrated on painting the actions of her opponent as mercenary. She accused Roger Chamberlain of pushing "opposition research against the DFL" without raising the attacks Chamberlain had purportedly engaged in and insisted he "wants to… defund public schools." #### Abortion

- Gustafson is pro-choice, has called abortion "healthcare," and signaled she opposes any restrictions on abortion, pledging to end "bills and laws... stripping women of their right to choose." ("Issues," Gustafson for Senate, Accessed 6/14/22; Twitter, 5/2/22; Twitter, 6/24/22)
  - O Gustafson pledged to "protect reproductive freedom and choice for Minnesotans" in her original campaign website and signaled she opposes any restriction on abortion, claiming such bills "are stripping women of their right to choose." ("Issues," Gustafson for Senate, Accessed 6/14/22)
  - In March 2022, Gustafson alleged that "anti-abortion and pro-life are not the same thing."
